# **Meeting Minutes**

### **Poultney Board of Selectmen**

### Monday, May 25, 2020 – 6:30 PM

#### **Poultney Town Hall**

Jeff King called the meeting to order. Selectmen present included: Jeff King, Terry Williams, and Carol Bunce. Others present included Paul A. **Adoption of the Agenda:** Terry Williams made a motion to adopt the agenda. Carol Bunce seconded the motion. Motion carried.

**Approval of Minutes:** Carol Bunce made a motion to approve the minutes of May 11, 2020. Terry Williams seconded the motion. Motion passed with all in favor.

**Public Comments and Concerns:** Discussion re: East Poultney Gorge Bridge. Paul Donaldson noted that the State of Vermont has confirmed the bridge can continue to be used by pedestrians and bicycles. Our insurance company, VLCT also has no objection to these uses. Carol Bunce made a motion to allow pedestrians and bicyclists to travel across the bridge while it remains closed to motorized travel as long as the State of Vermont deems it safe to remain so open. Terry Williams seconded the motion. Motion carried with all in favor. At this point, the board made no motion to allow snowmobiles to use the bridge, and will revisit this as winter approaches.

Discussion regarding continued inspections of the bridge to continue pedestrian and bicycle traffic. Paul Donaldson will inquire with the state as to how often the bridge will continue to be inspected.

Paul Donaldson stated the crew continues to maintain roads, and continues to do brush clearing.
