# **Meeting Minutes Poultney Selectboard**

# Monday, December 19, 2022 – 6:30 PM Poultney Town Hall

Jeff King called the meeting to order and led those present in reciting the Pledge of Allegiance. Selectmen present included: Jeff Jing, Terry Williams, Carol Bunce, Sheryl Porrier and Richard LaPierre. Others present included Paul A. Donaldson, Ronald Kelley, outgoing Highway Foreman, Dick Ferguson, Joel Roberts, incoming Highway Foreman, Katrina Davenport, Mark Teetor, Margaret Mug, and Mary Sue Reed. Attending via Zoom members included Mark and Kim Flynn, Janice B. Edwards, Sam Ferguson, Jane Williams, Alex Hilliard and Christina Kerber.

Adoption of the Agenda: Sheryl Porrier made a motion to adopt the Agenda. Richard LaPierre seconded the motion. Motion passed with all in favor.

**Approval of Minutes:** Carol Bunce made a motion to approve the minutes of 12-12-2022 and 12-14-2022 Emergency Budget Meeting. Terry Williams seconded the motion. Motion passed with all in favor.

### **Road Report:** Joel Roberts reported the following:

- -The International Tandem Truck is still in the diagnostic stages
- -They have been familiarizing the new drivers with their plow routes
- -AOT/VTrans has lent us a truck until next week. The truck got stuck once and we were unable to use sand just salt in the truck
- -the one ton truck is down as well
- -The 2014 Western Star has a broken main leaf spring, and will need to go to Westminster to be repaired
- -Hampton, NY loaned us a spare truck
- -The crew still needs to do roadside brush and tree pickup from the last storm

#### **Town Managers Report:**

-Katrina Davenport presented to the board that in order to stay in business the Poultney Rescue Squad needs to double its town allocation request. She believes with the additional funds they will be able to attract more fulltime employees. They also risk the chance of losing dispatch from Washington County, NY since short staffing makes it difficult to respond to calls. Alex Hilliard suggested that some grants may be available to the squad even though they are non-profit. Discussion on whether the squad should consolidate locations with the Fire Department and sell their facility. Katrina Davenport advised the board that in the past the squad board was not amenable to such a consolidation.
