Special Executive Session Meeting Minutes Poultney Selectboard

Monday, August 21, 2023 – 6:30 PM Poultney Town Hall

Jeff King called the meeting to order and led those present in reciting the Pledge of Allegiance. Selectmen present included: Jeff King, Sheryl Porrier, Alan-Glen Burnell and Mark Teetor. Others present included Paul A. Donaldson, Raj Bhakta, and Alex Hilliard. Members of the public appearing via Zoom were Mary Sue Reed and Daniel Norwood.

Adoption of the Agenda: Mark Teetor made a motion to adopt the Agenda. Sheryl Porrier seconded the motion. Motion passed with all in favor.

Public Comments and Concerns:

Alex Hilliard proved Paul Donaldson with a Letter of Interest to fill the vacant Selectboard position.

Mary Sue Reed asked who would be joining the board in Executive Session. Paul Donaldson informed her that it would be Raj Bhakta and Dan Norwood. She asked why the town attorney was not at the meeting. Jeff King informed her that we have been consulting with the Town Attorney on an on-going basis.
