Adoption of the Agenda: Mark Teetor made a motion to adopt the Agenda. Alan-Glen Burnell seconded the motion. Motion passed with all in favor.

State of Vermont Alternatives Presentation for South Street/Grove Street Bridge:

Vermont Counsel on Rural Development: Kim Rupe Lennox, Development and Communications Manager, Vermont Counsel on Rural Development, presented to the board an opportunity that VCRD has been thinking about for some time, and bringing a workshop to Poultney. She stated that VCRD is a non-political group that tries to connect people, and municipalities with different agencies in VT to try to accomplish goals and objectives for new ideas to develop in town. The board accepted Kim's offer to bring the workshops to town.

Citizen Concerns re: criminal activity in town: Dale Kerber, Constable, David Fox, Sheriff, RCSD, and Deputy Gregory Rickets, RCSD, presented to the public, some obstacles they face in dealing with juveniles in terms of law enforcement. Senator Terry Williams said he was willing to write and present bills to address these types of issues. There were many discussions, and comments from community members present on offering some solutions to criminal activity by minors from working with youths, and creating opportunities for the youth in town. Some members believe that creating more recreation opportunities will help curtail criminal behavior. Alex Hilliard and Mia Schultz said the community should participate in training to address underlying racism. There was discussion re: hazing, bullying, and harassment training.

Discussion re: starting a neighborhood Watch Program, and Sheriff Fox stated his department works with communities to train folks. The public gave the board a list of ideas. Sheryl Porrier stated the board will review the list and suggested members of the public pick one or two ideas out and try to implement them. A link to the meeting recording can be found here:
